Cocktail Style Events

Deep Water Lounge offers two formats for cocktail-style functions: an exclusive bar area package and a full venue hire. Both are designed to provide your guests with an exceptional experience in our carefully crafted spaces.

1.1 Bar Area — Exclusive Event Package

Capacity	Up to 50 guests (extendable to 80)
Exclusive Hire Trigger	30 guests or more
Minimum Spend	\$4,000 (food and beverage combined)
Duration	To be negotiated with the Functions Manager
Booking Confirmation	25% deposit of agreed package total

Our bar area is available for cocktail-style events and can comfortably seat 50 guests, with the flexibility to extend to 80 guests for a standing cocktail format. Any booking of 30 or more guests will trigger our Exclusive Event Package, meaning your group will have the space entirely to yourselves for the duration of the event.

All details — including timing, styling, and beverage arrangements — are negotiated directly with our Functions Manager. A minimum spend of \$4,000 applies to the event, inclusive of food and beverage.

1.2 Full Venue Hire

Minimum Guests	80
Maximum Guests	150 (as per our liquor licence)
Minimum Spend — Prime Sitting	\$12,000 (Friday & Saturday evenings)
Minimum Spend — All Other Times	\$8,000
Booking Confirmation	25% deposit of agreed package total

For larger events, we offer exclusive hire of the entire Deep Water Lounge. A minimum of 80 guests is required, with a maximum of 150 guests in accordance with our liquor licence conditions.

Prime sittings on Friday and Saturday evenings carry a minimum spend of \$12,000. All other time slots carry a minimum spend of \$8,000. Dates and times can be discussed on a case-by-case basis — please reach out to our Functions Manager to explore availability.

1.3 Beverage Options

Deep Water Lounge is committed to responsible service of alcohol and takes its RSA obligations seriously. We do not offer a fixed beverage package. Instead, hosts may select from the following arrangements:

- Pre-authorised spend — a set beverage budget is agreed in advance; once reached, the bar transitions to a cash bar for guests.
- Cash bar — all beverages are purchased individually by guests throughout the event.
- Host bar (open bar) — the host covers all beverage costs for the duration of the event. Please note that minimum spend requirements still apply.

Important: In the event that the minimum spend is not reached, the purchase of Deep Water Lounge gift vouchers is recommended to ensure the balance is honoured and your guests can enjoy a return visit.

Cocktail Menu

Our cocktail menu is designed for sharing and has been crafted to complement the atmosphere of Deep Water Lounge. The host is responsible for pre-selecting canape options from the menu below prior to the event. All selections must be confirmed with the Functions Manager at the time of finalising your package.

Seated Dining Events

For groups seeking a more formal dining experience, Deep Water Lounge offers two seated dining formats: an intimate private dining option in our Rose Room, and an exclusive restaurant hire for larger parties.

3.1 The Rose Room — Private Dining

Capacity	Up to 20 guests
Function Package Trigger	15 guests or more
Sitting Duration	4 hours
Minimum Spend	\$3,000 (inclusive of food and beverage)
Booking Confirmation	25% deposit of agreed package total

Our Rose Room is our dedicated private dining space, seating up to 20 guests. Groups of 8 to 14 guests may dine from our standard limited group menu. For groups of 15 and above, a set function menu applies.

The Rose Room is available for a 4-hour sitting. A minimum spend of \$3,000 applies for the duration of the sitting, inclusive of food and beverage. All menu selections must be finalised no later than 7 days prior to the event, along with a full guest list indicating each guest's meal preference and seating position within the group.

3.2 Exclusive Restaurant Hire

Capacity	40 to 70 guests (recommended)
Minimum Spend	\$8,000 (inclusive of food and beverage)
Sitting Duration	To be negotiated
Booking Confirmation	25% deposit of agreed package total

For groups larger than 20 guests, we recommend an exclusive restaurant hire. Hosting a group of this size alongside other diners would impact both the experience of your guests and our regular patrons; exclusive hire ensures a seamless event for everyone.

We recommend exclusive restaurant bookings for groups of 40 to 70 guests. A minimum spend of \$8,000 applies for the sitting. Please contact our Functions Manager to discuss timing, layout, and menu planning.

Set Menu Options

All function dining packages are based on our seasonal set menu. The menu will be drawn from our current dinner offering and must be agreed upon at least 7 days prior to the event. A full pre-order — including each guest's meal selections and seating position — is required before the event date.

Pre-drinks / starter items (olives, oysters) may be added to any package at standard menu pricing. Beverage arrangements follow the same options as outlined in the cocktail events section.

Booking & Confirmation

How to Book

All function enquiries are handled by our Functions Manager. To begin planning your event, please contact us at info@deepwaterlounge.com.au with your preferred date, approximate guest numbers, and event type.

Confirmation & Deposit

All bookings are confirmed upon receipt of a 25% deposit of the agreed function package total. This deposit will be deducted from your final bill on the day of the event.

Payment is processed via SevenRooms. Our Functions Manager will provide you with a payment link upon confirmation of your event details.

In the event that a minimum spend is not reached on the day, the remaining balance can be applied to Deep Water Lounge gift vouchers for future visits.

Terms & Conditions

By confirming your booking and paying the deposit, you agree to the following terms and conditions. Please read them carefully before signing.

1. Booking & Deposit

A deposit of 25% of the agreed function package total is required to confirm your booking. The deposit may be paid directly at the venue or via the SevenRooms booking system. Your booking is not confirmed until the deposit has been received. The deposit is applied in full to your final bill on the day of the event.

2. Cancellation Policy

Deep Water Lounge requires a minimum of 7 days' notice for all cancellations.

- Cancellations with more than 7 days' notice: the deposit will be refunded in full.
- Cancellations within 7 days of the event: the deposit is non-refundable.
- In the event that Deep Water Lounge must cancel your booking due to unforeseen circumstances, this will be managed on a case-by-case basis at management's discretion.

3. Minimum Spend

Minimum spend requirements vary by event type and venue area, as outlined in this package. If the minimum spend is not reached on the day, the outstanding balance may be applied to Deep Water Lounge gift vouchers for future use.

4. Food & Beverage

No external food or beverages may be brought into the venue. All food and drink must be supplied by Deep Water Lounge. Celebration cakes from an external supplier are permitted; a cake fee of \$10 per person applies. Deep Water Lounge is also able to arrange a custom cake upon request — please speak with your Functions Manager for details.

5. Responsible Service of Alcohol

Deep Water Lounge strictly adheres to Responsible Service of Alcohol (RSA) guidelines. We reserve the right to refuse service or entry to any person who is deemed to be intoxicated, behaving in an aggressive or disruptive manner, or who poses a risk to the safety and enjoyment of others. These decisions are at the sole discretion of management and staff, and the event organiser agrees to support staff in upholding these standards.

6. Damage & Liability

The event organiser accepts full responsibility for any damage caused to the venue, its furnishings, or equipment by themselves or their guests during the event. Any costs associated with such damage will be assessed by management and invoiced to the organiser following the event.

7. Noise & Finish Time

All events must conclude by the agreed finish time confirmed with your Functions Manager. Deep Water Lounge operates in compliance with applicable noise regulations and council requirements. The venue reserves the right to manage music levels and wind down proceedings in accordance with these obligations, without impact on the agreed terms of the event.

8. Venue Rights

Deep Water Lounge reserves the right to manage space allocation within the venue. In the event of capacity constraints or unforeseen circumstances, the venue may relocate your event to an alternative space of equivalent or greater suitability, or restrict access to certain areas of the venue.

9. Photography & Marketing

Deep Water Lounge may photograph or record events for use in marketing materials, including social media. If you do not wish for your event to be photographed for this purpose, please notify your Functions Manager in writing prior to the event date.
